

# **BULLETIN PST 302 – DELIVERY CHARGES** Background

BCSSGA members brought to our attention concerns regarding PST Bulletin 302 issued by the BC Ministry of Finance regarding PST on delivery charges. BCSSGA has reached out to the Ministry of Finance about this issue is advocating on your behalf. The below explanation was provided by the Ministry of Finance. We are continuing to press them on this issue. Should you have any questions or require further information, please contact Cailey Murphy at cailey@gravelbc.ca.

The change to **Bulletin PST 302 – Delivery Charges** is not a result of a change in the legislation. It is a correction of an error in the information relating to specific provisions of the Provincial Sales Tax Act (PSTA).

The bulletin on page 6 states "This bulletin has been rewritten to correct errors in the bulletin as to when [provincial sales tax] PST applies to delivery. The previous version of this bulletin incorrectly stated that delivery charges were not subject to PST for goods delivered in [British Columbia] BC, where title to the goods passed at the seller's premises. If you did not charge PST on delivery charges, as in the above scenario, on or before March 31, 2018, you will not be subject to a penalty. For more information, see Regulation 48/2018."

The PSTA requires (and has required since 2013) that the purchase price of taxable goods include delivery charges that are incurred at or before the time that title to the goods transfers to the purchaser. As mentioned above, Bulletin PST 302, suggested that delivery charges are not part of the taxable purchase price subject to PST if title to the goods passed to the purchaser at the seller's premise. The updated bulletin corrects this oversight.

In recognition that some businesses may have relied on the previous bulletin, a remission order called the **Provincial Sales Tax (Delivery Charge) Remission Regulation** (this is the Regulation 48/2018 referenced in the Bulletin) has been provided. The regulation provides remission for businesses that failed to levy tax on the portion of the purchase price that is a delivery charge if the sale occurred on or after April 1, 2013 and on or before March 31, 2018 and under the sale title to the goods passed to the purchaser at your premises that are in BC.

# **B.C. SOUTHERN INTERIOR TO GET 450 KILOMETRES** OF RESURFACING

BY B.C. MINISTRY OF TRANSPORTATION AND INFRASTRUCTURE

MAY 2, 2018 | A resurfacing project on Highway 5 near Barriere is now underway, marking the beginning of a busy season of resurfacing in the southern Interior region, covering more than 450 kilometres of highways and side roads.

"We have promised safer roads for the people of B.C., and paving more than 450 kilometres in this region alone this year will make a big difference to local residents and those traveling through the region," said Minister of Transportation and Infrastructure Claire Trevena. "By maintaining high-quality roads and highways, we are improving peoples' safety and keeping commercial goods moving."


This first project on Highway 5, between Agate Bay Road and Darfield, includes 16 kilometres of resurfacing. Dawson Construction of Kamloops was awarded the \$4.6-million contract for the work, which is now underway and is expected to be completed this spring.

More than \$85 million is being invested in highway and side road improvements in the southern Interior in 2018. Other major resurfacing projects taking place in the region this spring and summer include:

- Highway 3/95 near Creston Resurfacing 36 kilometres of Highway 3, from Arrow Creek Road to Yahk; 11 kilometres of Highway 95, from Kingsgate to Curzon; and 23.5 kilometres of selected side roads in the Kitchener, Arrow Creek, Kidd Creek, Kingsgate, Yahk and Moyie areas.
- Highway 5 near Merritt From Portia Bridge to Kingsvale, resurfacing 38 kilometres of the Coquihalla Highway.
- Highway 12 near Lillooet 46 kilometres of resurfacing from Lytton to Lillooet, and 2.5 kilometres of overlay paving on Road 40, north of Lillooet, from Hollywood Crescent to Dickie Creek Bridge.
- Highway 26 near Quesnel Resurfacing 44 kilometres, from Wingdam to Barkerville.
- Highway 97 in Kelowna 4.6 kilometres of resurfacing, from Gordon Drive to the junction with Highway 33; 5.6 kilometres, from Edwards Street to Old Vernon Road; and 5.5 kilometres on Old Vernon Road, from Spencer to McKenzie. In addition, there will be intermittent paving between Abbott Street and Gordon Drive.

The following projects make up the rest of what will be resurfaced in the southern Interior in 2018:

• Highway 1, from Glacier National Park to Donald Bridge and selected side roads near



Golden (37 kilometres)

- Highway 3, from Kootenay Pass Summit to Summit Creek near Creston (28 kilometres)
- Highway 3 and 3A, from Ooteschenia near Castlegar to Playmor Junction at South Slocan (20 kilometres)
- Highway 5, from the Nicola Interchange to Clapperton Brake Check and Coldwater Road near Merritt (32.5 kilometres)
- Highway 20, from Jourdenais Road near Hagensborg to Atnarko Slough (50 kilometres)
- Highway 20, from Redstone to the Alexis Creek/Nazko Road and McCullough Road (26 kilometres)
- Highway 24, from the brake check to Highway 24/5 Junction near Little Fort (13 kilometres)
- Highway 97, from Deep Creek Bridge near Peachland to Glenrosa Road in West Kelowna (15 kilometres)
- Chimney Lake Road and other side roads in Williams Lake (28.5 kilometres)
- North Fork Road north near Grand Forks (25 kilometres)

While these resurfacing projects are underway, drivers can expect minor delays and, at times, single-lane alternating traffic. The ministry appreciates peoples' patience while this work is taking place.

Drivers are reminded to slow down, obey traffic control personnel, and to check **DriveBC.ca** for the most up-todate highway information.

### **ASGA TALKS TRUCKS** Truck Registry Program a key focus for 2018 BY ANDREW SNOOK



The Alberta Sand & Gravel Association's (ASGA) Truck Registry Program is a top priority for 2018

ASGA president Dale Soetaert (Lehigh Hanson Materials) offered an update on the ASGA Truck Registry Program to members during the association's 2018 annual general meeting in January at the Marriott Edmonton River Cree Resort in Enoch, Alta.

The program had experienced a decline in the number of registered trucks this past year.

Soetaert stressed the importance of the program to attendees in terms of revenue generation for the association, consistency and enforcement. The program was started in 2004.

"It's a self-check that we can do as an industry to show municipalities that we care," Soetaert told the crowd.

He added that the No. 1 complaint the industry receives from the general public is related to gravel trucks, and that if industry doesn't manage the issue of truck complaints, it could end up being managed by another party.

A Truck Registry Sub-Committee has been created to deal with issues related to the program with BURNCO Rock Products' Travis Coates leading the sub-committee as chair.

Rock to Road sat down with both Coates and Soetaert during the AGM to discuss future plans for the program. Coates said that there are three core improvements that he would like to see made in 2018.

The first improvement is an automated complaint follow-up system, which will generate reminders to companies to follow up on complaints they receive from the public, which will improve relationships between producers, citizens and municipalities. "Having a system to better facilitate this would be huge," Coates says.

Another change that ASGA would like to make to the truck registry is to expand who is able to register for the program. Under the current format, only producer members can register. Allowing non-producer members to register will increase participation in the program while allowing producers the ability to see a driver's history and any complaints lodged against them.

Soetaert says this feature will make it easier for producers to introduce suspensions or other types of disciplinary actions against drivers that are receiving complaints against them from citizens.

Coates adds that holding drivers more accountable for their actions will be good for business and force some drivers to be more responsible on the roads; while at the same time reward those drivers that have none, or very few, complaints lodged against them from citizens.

The third core improvement ASGA is looking to add to the program in 2018 is the ability to generate more standardized responses that producers can then use or tweak to help save time when dealing with more common complaints from the public.

"We feel there's room for more common complaints having standardized responses," Coates says, adding that having these available to non-producers could make life easier for the hauling companies, giving them the ability to deal with complaints in an efficient manner.

"Municipalities appreciate having the ability to call and find who the drivers are," Soetaert adds.

ASGA met with Calgary City Council members in June 2017, and Edmonton City Council members this past December to discuss the possibility of making the truck registry mandatory in both cities.

Soetaert and Coates are both excited to have all of these initiatives on the agenda for 2018.

"There's always room for improvement," Soetaert says. "We've received feedback from members so we're getting some changes done to address that."

# MANDATORY MINE SUPERVISOR'S CERTIFICATION WILL BE AVAILABLE SOON ONLINE

In February 2017, the Ministry of Energy, Mines and Petroleum Resources (EMPR) completed a review of the Health, Safety and Reclamation Code for Mines in British Columbia (the Code).

One of the new provisions added to the Code was the reintroduction of a Mine Supervisor's Certification for any supervisor on a mine site to ensure a common understanding of the Code, to encourage worker safety and to ensure supervisors on a mine site are aware of their responsibilities under the Code. The Mine Supervisor Certification was launched April 16, 2018 and the Code requirement came into force June 1, 2018.

The provision requires that anyone supervising six or fewer people on an active mine operation or in other areas of a mine, such as a mill, tailings storage facility, lab or maintenance area or shop, must complete their Supervisor's Certification. It applies to all mine sites in the province including major mines, exploration sites, sand and gravel and placer operations and quarries.

In order to facilitate a large volume of registrants, ensure easy access and provide a tracking option for compliance, an online delivery option for certification was identified as the preferred delivery method. This enables supervisors to complete the program online from anywhere and work at their own pace.

The Mine Supervisor's Certification is a comprehensive and custom program designed specifically for on-site supervisors in any sector of B.C.'s mining industry. The online delivery has eliminated the need for in-house examinations, increased the consistency of information delivery, and provided real-time tracking of completed certifications for compliance purposes. To-date, more than 1800 people have obtained their certification.

EMPR worked with Open School BC from the Ministry of Education to develop and deliver the program. Open School assists with instructional design, educational resource development and online course offerings specifically for government-led educational programs. Open School has a track record of creating educational and training solutions for organizations such as school districts, ministries and Crown corporations.

Stakeholders from each of the mining sectors, including labour, were included in the development of the program.

The cost to become certified is \$100 and participants receive a temporary certificate immediately upon successful completion of the program; their official certificate will be mailed to them. Funds recovered from the certification program will support subscription costs for use of the online software as well as further development and updating of certification programs. The certificate must be re-taken every five years.

# **MINE SUPERVISOR CERTIFICATION – Q&A**

#### What is the Mine Supervisor Certification?

The Ministry of Energy, Mines and Petroleum Resources (EMPR) completed a review, with First Nations, industry and labour, of specific portions of the Health, Safety and Reclamation Code for Mines in British Columbia (the Code). As a result of the review and consensus recommendations from all parties, new provisions came into force February 2017.

One of the new provisions added to the Code was the reintroduction of a Supervisor's Certification for any supervisor on a mine site to ensure a common understanding of the Code, to encourage worker safety and to ensure supervisors on a mine site are aware of their responsibilities under the Code.

#### When do I have to have my certification by?

This requirement comes into force on June 1, 2018.

#### Who has to have their Mine Supervisor Certification?

The provision requires that anyone supervising six or fewer people in open pit mining activities or any number of employees on exploration sites or in other areas of a mine, such as a mill, tailings storage facility, lab or maintenance area or shop, must complete their Supervisor's Certification. This provision applies to all mine sites in the province including major mines, exploration sites, sand and gravel and placer operations and quarries.

#### Some examples below:

- A supervisor who supervises any number of employees on an exploration site will need a MineSupervisor certification.
- A supervisor on a sand and gravel operation who supervises 10 employees in mining activities will need a Shiftboss certification.

- A supervisor at a major mine who supervises 20 employees in a maintenance shop will need aMine Supervisor Certification.
- A supervisor on a small mining operation who supervises 5 employees in mining activities willneed a Mine Supervisor Certification.
- One person on a placer site that does mechanical surface disturbance will need a MineSupervisor Certification.

# If I have my Shiftboss certification – do I need a Mine Supervisor Certificate?

No, if you have a valid Shiftboss certification, you do not need a Mine Supervisor Certificate.

# What is the purpose of the Mine Supervisor Certification?

The certification was initiated and created to develop and enhance a working knowledge and enable navigation of the code and to test awareness of regulatory responsibilities as a Supervisor in mines in BC

#### Once I complete the certification, does this mean that I have the skills to be a Mine Supervisor on an active mine site?

The certification is not intended to replace or provide technical training on health and safety procedures, knowledge or ability. Each mine must provide their own Supervisor training program tailored to their site.

# Are there specific certification exams for each area of the mining industry?

The Mines Supervisor Certification is deliberately not tailored to any specialization. Not every Part of the Code may be in regular use at every type of mining operation and all Parts of the Code are applicable to every mine site depending on the situation.

The certification is intended to be transferrable from region to region, and from one mine type to another.

For example: If a supervisor with a valid Certification works in a gravel quarry, and then goes on to work in exploration, their Mines Supervisor Certificate is transferable with them.

#### Who put together the Mine Supervisor Certification?

The Ministry of Energy, Mines and Petroleum Resources, along with OpenSchool BC developed the certification. However, the framework for the certification was developed with industry and stakeholder input, with participation from major mines, quarries, sand and gravel, exploration and placer.

#### How long is the certification program?

The exam has 100 questions and no two exams will be the same.

Pilot testing indicated it took, on average, four hours to complete (but that may increase or decrease depending on your knowledge of the Code), with the shortest being 1.5 hours and the longest being six hours.

The certification program is active for each registrant for six weeks from the date of registration – meaning you can take as long or as little time as you like to complete

#### What is the passing grade?

The passing grade is 80% and each student gets three tries to pass. The exam is fully open book and you may stop and start the exam as many times as you like.

#### How much is the certification program and will I have to take it again? How come it is not free like other certifications?

The Mine Supervisor Certification is \$100 and is valid for five years. Funds recovered from the certification program will support subscription costs for use of the online software and further development and updating of the certification programs.

### Is it possible to purchase multiple seats for my employees?

Yes, the system allows a bulk buy. Once the purchase is complete, a unique link will be generated to distribute to your employees so they can complete their registration and certification on their own.

#### I have taken the program from the College of the Rockies previously, is this program the same as the Mine Supervisor?

No, the College of the Rockies program is not the same as the Code required Mine Supervisor Certification. You must obtain the government certification. However, if you have completed their program, it will definitely help you successfully complete the exam. We are hoping to make an arrangement in the future to have the Mine Supervisor Certification included as part of the College of the Rockies program.

#### What about the other certifications that EMPR offers?

#### AGGREGATES BUILD BC

EMPR is currently working to modernize and update other certifications such as Blasting, Shiftboss and Fireboss. A small fee will be charged once they have been updated to cover the cost to administer and continue to update those certifications.

What do I do if I lose or misplace my certificate? Crown Publications can re-print and mail you a new certificate and wallet card. A \$10 fee is charged to cover printing, shipping and handling.



# **2018 PERMIT FEE AMENDMENTS**

#### BACKGROUND

- Permit fees were implemented in 2015 following consultation with industry and a public discussion paper.
- EMPR staff consulted with BCSSGA in June and October of 2016 on permit fee changes in anticipation of the changes being made effective April 1, 2017. BCSSGA indicated that it understood the need for the changes and accepted the proposed amendments.
- However, due to timing issues, the Province did not proceed with the changes in 2017.
- EMPR staff updated the BCSSGA in February 2018 on the upcoming permit fee changes (implementation target is early fiscal 2018).
- Permit fee revenue is intended to provide some cost recovery of EMPR's permitting service specifically to replace the contingency funding that EMPR had relied on to achieve reductions in permit application turnaround times.
- Permit fees were forecasted to generate \$1.SM from gravel pits/quarries based on production data the Ministry had access to. To date permit fee revenue from pits and quarries has been approximately \$1M per year less than forecasted.
- Permit fee revenue represents a key part of EMPR's fiscal plan however, this revenue is marked as 'recovery to vote' meaning that EMPR only receives what it collects in permit fees. EMPR must absorb

any permit fee revenue shortfalls and make the necessary budgetary adjustments each year.

#### **PERMIT FEE CHANGES**

- The amendments make the following fee adjustments:
  - A general increase to permit fee amounts.
  - A lower initial threshold so fees are paid beginning at 5,000 tons per year instead of 10,000 tons per year.
  - Additional incremental fee steps 13 fee steps instead of 4.
  - Eliminate the distinction between short and long term operations (no longer different fees for pits or quarries operating 5 years or less and more than 5 years)
- These amendments remain consistent with the following key principles articulated during initial consultations:
  - Fees should contribute to partial cost recovery for the permitting services provided by EMPR,
  - Fees should minimize the impact of fees on small operations (smaller operations paying smaller fees or no fees), and
  - Fees should not exceed 6 cents per ton on extracted material over a 5 year period.

# SAFETY HSRC PROJECT

#### **BY DANI MILLER**

The BC Construction Safety Association (BCCSA) has teamed up with the BCSSGA to try and make life a little simpler for Mine Managers, Supervisors, Shift Bosses and ownership across the province. All mines in BC are required to follow the Health, Safety and Reclamation Code for British Columbia mines (The Code). Those of us in "Pits and Quarries" though, know that only about 60% of that Code applies to our operations. Most of us have struggled from time to time finding the rule we're looking for in the code. It's easy to get confused when you look up the word "drilling", then realize half a page later the section you are reading only applies to underground drilling.

This has always been a frustration, a source of confusion and a time-robber for every level of supervision. When it comes to safety, we all know - complication is the root of all evil. So, we've found a partner to help us make the code less complicated. The BCCSA has hired a consultant, who has edited the Code down to only the Pit and Quarry applicable sections just for us. Hoists, shafts, underground, mineral specific, mineral and coal tailings dams – those lengthy, complicated and not-applicableto-us sections have been deleted and we will shortly have a reference book that is 40% thinner, with 100% less chance you'll start reading the wrong thing and applying the wrong rule. The resulting subset will help speed up the day-to day questions and answers and reduce the chance of error, without changing the meaning or application of the full Code, which will always be the 'governing document'.

The big picture here – the less time we spend in our offices reading, the more time we spend out with our teams supervising, mentoring and really, improving safety. We need to know the rules but we don't need to be 'rule book experts'. We all need to be 'safety leadership experts' which means, let's make less mistakes, get off the desk faster and get out to the front line where we can have an impact with our presence, experience and attitude.

This project is funded in part by the BCSSGA, and in part by the BCCSA – who is funded in part by YOU via your WorkSafeBC premiums. They are a fantastic, flexible resource to help with prevention, training and cost savings via CoR. You can look forward to seeing more about them in upcoming meetings and newsletters as we start to tap into this amazing resource.
