- $Encourage\ individuals, organizations, and companies\ to implement\ programs, policies, safety\ protocols\ or\ onsite\ practices\ which\ improve\ the\ health\ and\ safety\ of\ workers\ and\ the\ surrounding\ community.$

#### **Award Criteria:**

This award recognizes all types of health and safety initiatives or innovations. The purpose of this award is to encourage the sharing of forward-thinking ideas which have been implemented to create a safer, healthier work environment, and practices which go beyond what is considered routine in the industry.

- 1. Description
- 2. Effectiveness: eg. how it reduces risk with regards to safety or improved by innovation
- 3. Significance: eg. how the initiative has positively impacted the overall health and safety of your workplace and organization and possible future benefits?
- 4. Relevance: eg. how will your initiative improve the industry overall
- 5. Operating Areas or Project that safety or innovation applies
