I feel like there are still mountains of work ahead, but we've kept this train rolling in a good direction focused on making life better for Producers and, the Regulators who are, no matter your opinion on the government of the day, our partners.

Our successes are cumulative and it's amazing we have an organization where, our plans, agendas, and strategies don't change with the wind or each new leader. Derek, then Tyson started on

### **Committee Updates**

#### **Government Relations Committee**

The Government Relations (GR) Committee is tasked with addressing the most pressing matters for membership with law-makers and regulators from the various levels of government. Our goal is to meet as often as necessary with representatives from government and advocate for both the industry and membership in terms of policy, legislation, strategic direction and mandates. While individual matters are not tackled directly, they often lead the committee in search of root causes and most of all development of solutions which we can work through with government. Our regional representatives play an important role on the committee as they bring forward news and emerging issues from across the province for review and consideration.

Permitting timelines, efficiency and the burdens caused by each of these on our membership continued to be an issue at the forefront of our committee this year. We met regularly with senior Ministry staff to understand root causes for delay as well as communicate possible efficiencies to Membership. Full implementation of the Mine Plan Update Policy came in to effect this past year allowing permit holders who met the criteria of the policy to stay compliant with their plan updates by submitting them to the Mine Space portal without paying application fees or waiting for review.

We also advocated for de-regulating permitted pits and quarries from wholesale changes to the Contaminated Sites Regulation. While some of the details of this work are ongoing, materials coming from and going to a permitted mine site are exempt.

As we look forward to our next year of work, coordination of permits, licences and authorizations to allow aggregate mining is on the horizon. Our next job is focused on an application guideline manual which will dovetail nicely with the ultimate goal of a fully integrated and single window decision process, hopefully with one statutory decision maker. Aim




