President's Message

Happy almost spring everyone. We are almost out of winter up here in the northern half of the province.

There have been some cold and uncertain winds blowing up to Canada from the President of the USA regarding our long-standing trade relationship and new tariffs with Canada. The old saying "when one door closes, another door opens" is as true today as ever. The law of unintended consequences may be the silver lining for us in all this if we can manage to break down inter-provincial trade barriers and seek out new trade partnerships abroad. With our Prime Minister stepping down and Mark Carney taking over that position a federal election is going to be called soon. Personally, I think we stand a much better chance of negotiating with the American government with a new and not Mr. Trudeau. I was recently in Mexico and met a very nice American couple on the beach from Minnesota. When I asked how their trip was going, they replied "we are on the apology tour for all Canadian and Mexican people we meet who have been insulted by our president." Quite a statement!

Some positive changes have come from the mandate letters provided by the Premier to Minister Brar and his team. These initiatives were unveiled at the BC Natural Resources Forum this past January in Prince George. The message was clear, the government wants to fast-track projects and streamline permitting processes to keep BC competitive and moving forward. With interest rates recently dropping another 25 basis points we now have the lowest interest rates since 2022; this should also help to keep our economy going in a positive direction.

Education. So, what is the update there? We are getting close to the finish line to being able to offer our first safety training courses. Derek has done a fabulous job working with our consultant from Ontario to transform the training manual, so it has direct relevance to our BC rules and regulations. I can't give a firm date on the first class other than I will attend it sometime in 2025.

I would like to thank Derek and our elected Board

of Directors for putting up with me for the last 2 years. I have so much respect for the depth of knowledge that they bring to our Association. We are becoming better represented all over the province with the addition of our new board members in the north.



Derek Holmes has such a solid understanding how to have our association be heard and work in a positive direction with government on all levels.

I would like to thank Victoria Holmes for all her amazing work. You are truly the glue that keeps this organization together with your weekly updates, incredible venue planning and keeping Derek in line.

Thanks, it has been an honor to serve as the president of our association and meet so many new friends! I look forward to working with our upcoming new president David Rogalsky. David is a first-class gentleman who I know will make a difference.

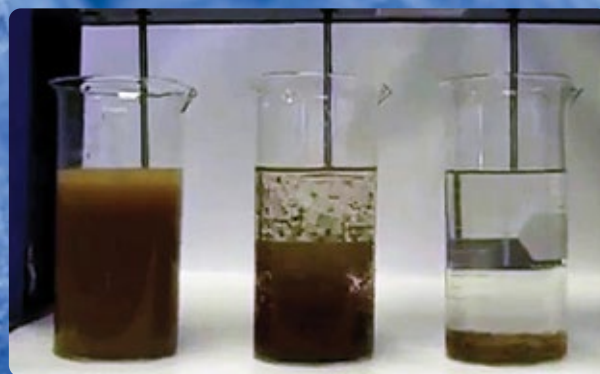

Committee Updates

Government Relations Committee:

The Government Relations (GR) Committee is tasked with addressing the most pressing matters for membership with law-makers and regulators from the various levels of government. Along with the Safety Committee it is one of the core groups of your Association and meets both internally on a monthly basis as well as with government after every meeting. We've developed a strong working relationship with the Ministry of Mining and Critical Minerals both at a Ministerial level and, perhaps more importantly, with senior members of the bureaucracy who are more permanent than the elected ones.

We have a very focused, hard working group of volunteers on the committee from around the province who I would like to personally thank for their time. Lance Dexter, Kurt Strachan, David Rogalsky, Barry McLean, Dani Miller, Barry Chalmers, Tyson Craigs and Rick Kovach, thank you for your time, the early morning meetings and bringing your invaluable knowledge and insight to help move our initiatives forward. Continuing our work from 2023 and 2024 we kept our focus on permitting timelines, efficiency and reducing red tape for new and existing aggregate producers.

Our members and producers from around the province have benefitted from the launch of the Aggregate Guidance Document in 2024. To our knowledge this Guide has been used by all Inspectors from across the province when considering new permit and permit amendment applications in every mining region and resulted in more consistency with respect to application requirements. The election last fall resulted in a new Minister and Ministry name (welcome Honourable Jagrup Brar, Minister of Mining and Critical Minerals) as well as fresh mandate letters from Premier Eby released in January. In the mandate letter new emphasis has been given to tackling the permitting problems in the province which, along with geo-political tensions to our southern border, has brought some focus to a major initiative we launched last year – delegated authorities for decision making. The energy sector has benefitted tremendously from this “one-window” permitting model and the Ministry of Mining is



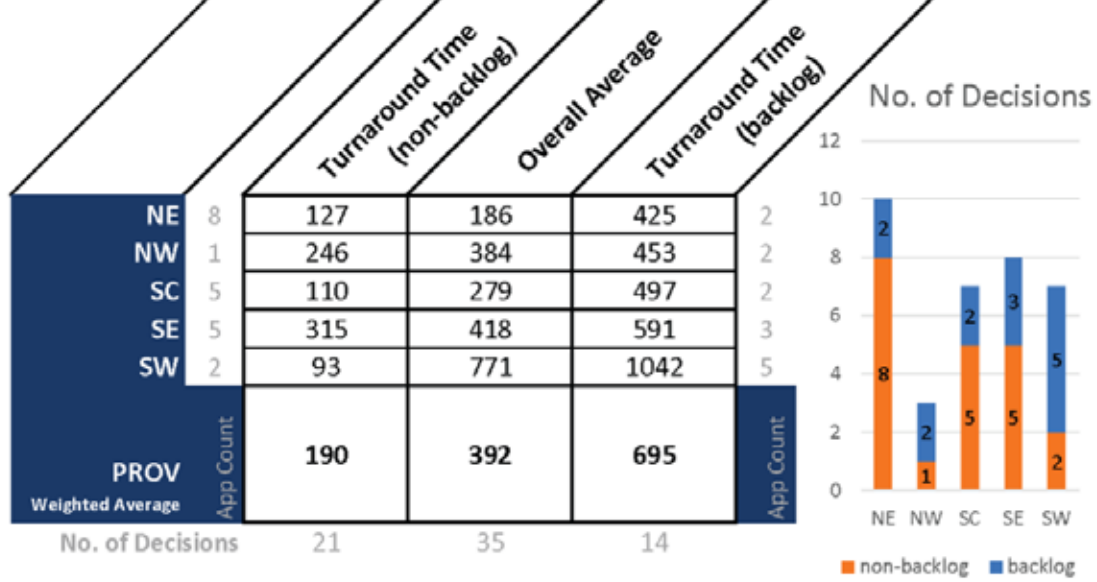

Regional Mines Permitting Report

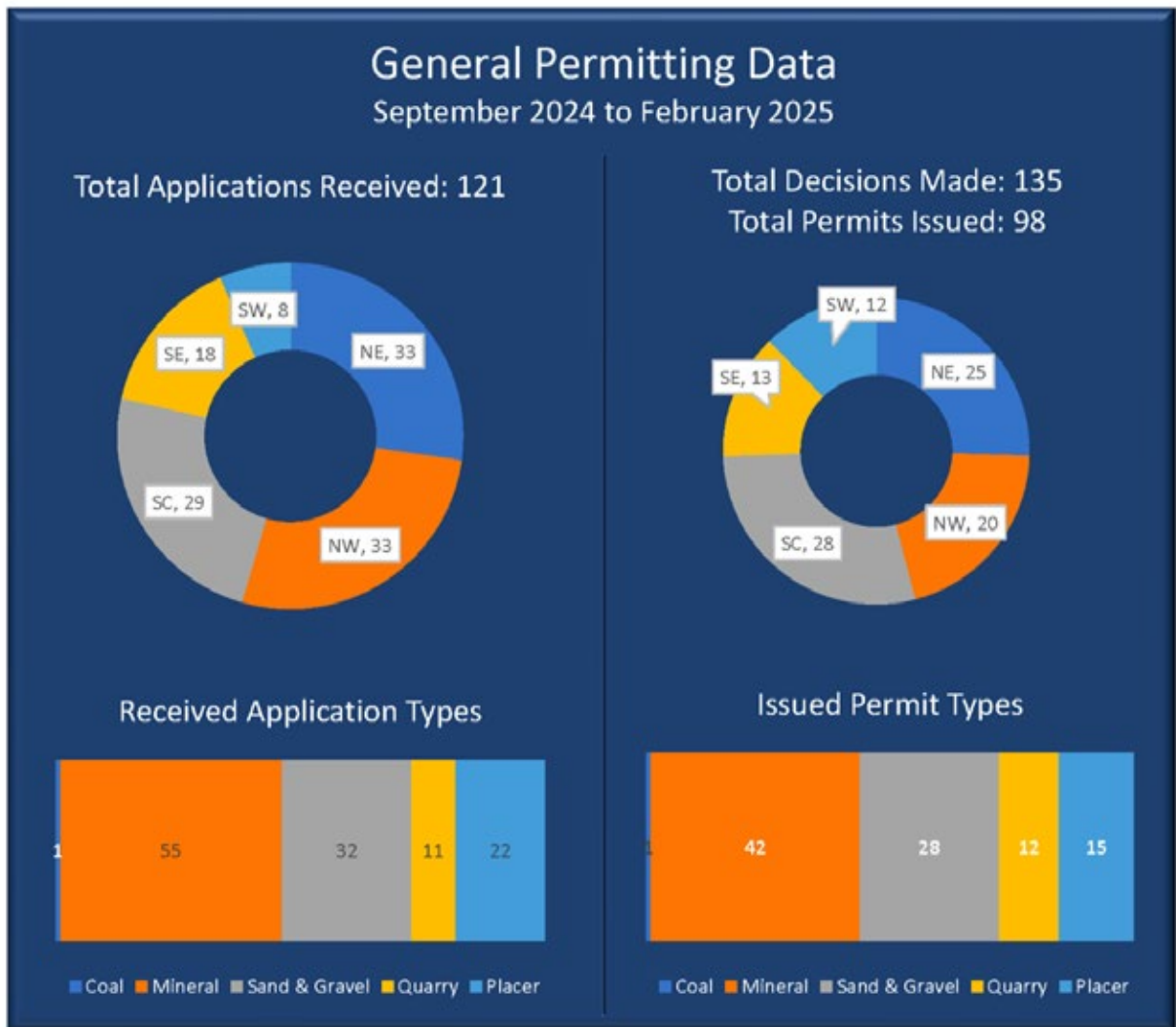
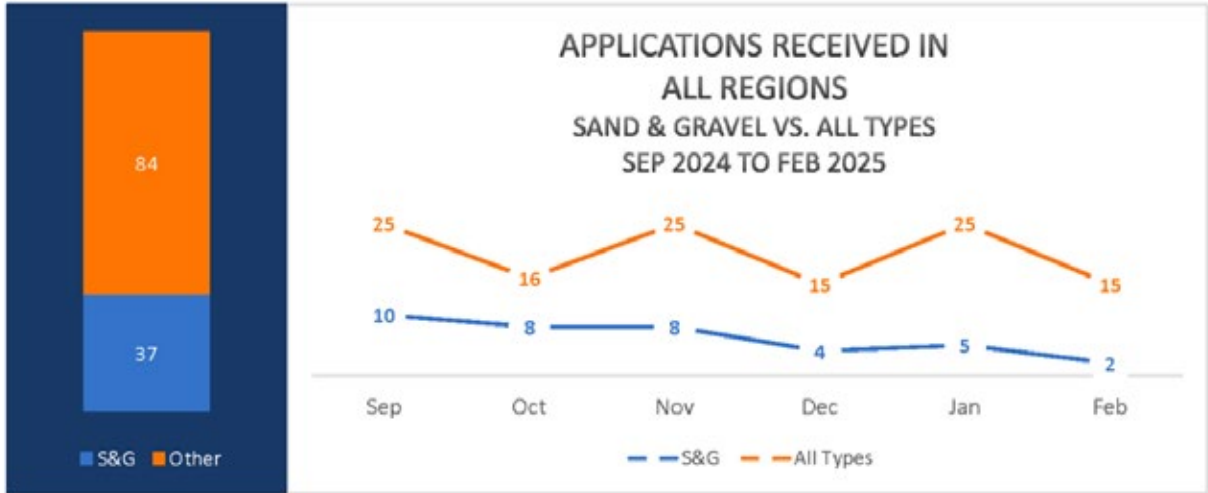
Sand and Gravel Average Turnaround Time Sep 2024 to Feb 2025 Net Duration (Total Duration minus Proponent Delay)

From the Safety Committee:

I'm pleased to introduce myself as the new Chair of the BCSSGA Safety Committee. Having spent over 25 years in the aggregates, road construction, and ready-mix industries, safety has been at the core of my career. From my early days working on-site to my current role as Health, Safety, and Environmental Manager at Terus Construction, I've seen firsthand how strong safety programs protect our people, improve operational performance, and drive a culture of continuous improvement.

As Chair, my primary focus will be to help the committee advance two key priorities: strengthening industry training and raising awareness about emerging safety technology and innovation. Our industry is evolving rapidly — from wearable technology that enhances lone worker safety to AI tools that support incident investigations to equipment outfitted with advanced proximity sensors — and we want to ensure BCSSGA members have access to the latest information and practical tools to support their teams.

Building a substantial, consistent industry training standard will help improve safety outcomes and

The safety committee is also dedicated to providing resources for small operators to ensure their business has the latest and most up to date information available for their safety program.

Becoming a member in the Association ensures we

have the numbers and resources to stay relevant with government and non-government entities. Producers benefit by having a strong industry voice advocating for them so they can stay focused on their business and regular updates and meetings to share and learn from others. We have government representatives attend and speak at every one of our meetings. 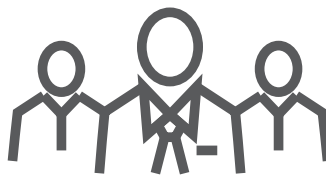

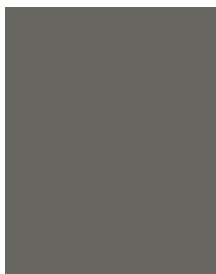

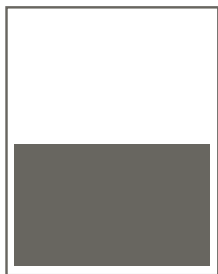
